## Live Competition Terms and Conditions

- 1. ForexBoat and AxiTrader ("The Sponsors") promote a Live Trading Competition ("Live Competition")
- 2. For participating in this Live Competition, you have to register for the contest providing the details requested (first name, last name, phone, email, country & nickname) and be approved for a trading account as well to be over 18 years old. All details provided during the registration should be correct (i.e. full name details to match the proof of identity, proof of residence to match the country of residence, etc.) otherwise the participants or winners will be disqualified from the Live Competition.
- 3. ForexBoat's and AxiTrader's personnel cannot participate in the Live Competition.
- 4. The Live Competition is available to new clients or existing Clients who register for this offer with a sub-account.
- 5. For participating in the Live Competition, you have to register, make a minimum deposit of 250 USD and be approved for a trading account based on AxiTrader's Account Opening procedures and rules.
- 6. By participating in the Live Competition, you acknowledge that you have read and agreed to be bound by these Terms and Conditions as well to the Business Terms and Conditions of the entity with which you have decided to proceed with registration via the dedicated competition registration page of such entity. - c. All participants who registered via the dedicated competition registration page should declare a *nickname* that will be used for ranking purposes.
- d. AxiTrader does not offer accounts to US or Japanese residents

9. The Live Competition winners will be determined as per below factor(s):

Winning Formula: (Net Profit/Deposits) x 100

- The winners will be those with the highest returns on the closing market on 29th May 2020.
- Net Profit stands for Realized and Unrealized Profit and Loss.
- Deposit stands for the total amount deposited during the Live Competition period.

## Example A:

Total Deposits for the period:1500 USDNet Profit for the period:4500 USD

## Returns = (Net Profit/ Deposits) = (4500/1500) x 100 = 300%

**Example B:** Total Deposits for the period: 500 USD Net Profit for the period: 4500 USD

## Returns = (Net Profit/ Deposits) = (4500/500) x 100 = 900%

- 10. For the award prices to be added as trading credit into the winners' trading account, the winners will have to:
  - a. Meet and must have already passed AxiTrader's compliance procedures and check; and

- b. Provide a detailed report of his/her Live Account when and if required by AxiTrader or ForexBoat.
